PAYMENTS ON ACCOUNT

Customers on the Beaulieu River are entitled to purchase fuel and services at Buckler's Hard Yacht Harbour on account. In order to make the payment of accounts simpler we have a system of payment by direct debit.

The system works in the following way:

- You will request your fuel/services as per usual
- An invoice will be sent to you via email detailing the amount to be collected by direct debit.
- We will request payment from your bank at the end of the month following the month of purchase.

Of course you will also have the option to pay for fuel or services on the day by cash or card.

Please note that payment for **annual mooring/berthing fees** will **NOT** be collected from the direct debit.

If you wish to be able to purchase fuel and services on account, please complete the tear off section above and attached direct debit form and return them both to the Harbour Office, Buckler's Hard Yacht Harbour, Buckler's Hard, Beaulieu, Hampshire, SO42 7XB.

- If an error is made in the payment of your Direct Debit, by Beaulieu Enterprises Ltd or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society
 - If you receive a refund you are not entitled to, you must pay it back when Beaulieu Enterprises Ltd asks you to
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
